

### **About the Center**

The Center for Apologetics and Worldviews (CAW), under the supervision of the Evangelical Lutheran Synod and its Board on Apologetics, promotes evidence for the truth of Christianity and identifies and critiques worldviews at odds with the Christian worldview. We do so to fortify Christians in biblical truth and prepare them to defend the truth—with gentleness and respect—so Christ may be shared wisely and boldly in these challenging days.

As a confessional Lutheran center, we necessarily include important and distinctive biblical teachings in our approach to apologetics. We recognize "God has given me my reason and all my senses" while confessing "I cannot by my own reason or strength believe in Jesus Christ my Lord or come to him" (Luther's *Small Catechism*).

We are currently the only Lutheran church body that has established a synodical board and center to carry out this work (though we hope others will soon follow). By God's grace, we will encourage and help Christians to "be prepared to give a defense to anyone who asks you to give a reason for the hope that is in you." (1 Peter 3:15)

The CAW was established in July of 2020 at the urging of now-sainted synod president John Moldstad, Jr. Rev. David Thompson serves as the director under the direction of the Board on Apologetics. Though CAW is a synod endeavor, it is self-supporting and dependent on donations for conferences, presentations around the country, production of resources, salary, office space, etc.
